

CONDITIONS AND USE POLICY

WELCOME TO THE BIG HORN EVENTS CENTER! We are pleased that we are able to provide you an affordable, fun, family option for your stay during the *Mars Big Horn Soccer Cup*. Please know that you are being allowed to stay overnight on a trial basis this year. Your respect for our facility and the surrounding homeowners will determine if families will have this opportunity for years to come.

DAY PASSES:

There will be a special gate for all RVs, which will be marked: For a day pass only, you are allowed to park your RV for a \$5 parking pass (some of you may have already purchased a pass).

OVERNIGHT CAMPING:

This year, your family can enjoy overnight accommodations at the Big Horn Events Center. Our fee of \$100 will enable you to park your RVs / campers overnight from Friday evening through Sunday afternoon in our **specifically designated location**. **NO TRESPASSING ON SURROUNDING PROPERTIES**. The gates will open at 4pm Friday afternoon. There will be marked spaces for camping, accessible through a separate entrance into the Center.

Overnight accommodations do not provide water, electric, or sewage. Generators will be permitted; however please use them respectfully. Portable units and trash receptacles will be on site. Upon registration, campers will need to sign below after thoroughly reading all conditions stated in this document.

The undersigned agree to personally indemnify, hold harmless and defend the BHEC from claims arising out of any person's attendance at or use of the BHEC facilities incident to the use of the BHEC facilities under this agreement, including but not limited to, all claims for property damage or personal injury on or off the BHEC premises.
